0 Purpose

This document lists the verifications of suitability for drinking water hygiene that must be provided for type approval certificates.

1 Scope

This document applies to all certification programmes ZPs for products, components and parts intended for use in the drinking water sector and are to be certified as part of a DVGW type approval test.

2 Period until 31 December 2026

2.1 General requirements

Only the requirements applicable in Germany apply.

2.2 Types of Verification/ Evidence

The national German requirements can be verified as follows:

- Hygiene attestations of conformity for the composite product, issued by a certification body accredited for the procedure.
- Alternatively: Hygiene attestations of conformity for parts and/or their components.

The following applies to verification at component level:

- Product group P1 or A/B and P2 or C:
Hygiene attestations conformity, issued by a certification body accredited for the procedure
- Product group P3 or D:
Hygiene attestations conformity issued by a certification body accredited for the procedure
or a test report issued by a testing laboratory recognised by DVGW CERT for the procedure.
- Product group P4:
Test report issued by a testing centre recognised by DVGW CERT for the procedure.

3 Period from 1 January 2027

EU- Attestations of conformity for the composite product or its component parts, in accordance with the minimum hygiene requirements specified in Implementing Decision (EU) 2024/368, issued by a certification body accredited and notified for the procedure.

Alternatively, or in addition, **national** (German) hygiene verifications of conformity as described above may be submitted. (Note: National hygiene attestations of conformity can only be issued until 31 December 2026).

4 Period from 1 January 2033

EU- Attestation of conformity for the composite product in accordance with the minimum hygiene requirements laid down in Implementing Decision (EU) 2024/368, issued by a certification body accredited and notified for the procedure.

5 Applicable documents
